1. ~~INVOLVED~~ INVOLVED 13 DEC AUTO ACCIDENT NOT OPERATIONALLY JUSTIFIED IN WHICH HE/ QP CAR AND OCCUPANT OTHER CAR INJURED. NO SERIOUS INJURIES BUT BOTH CARS DAMAGED SEVERELY. DUE INVOLVED LEGAL PROCESS QP CAR STILL NOT RELEASED BY AUTHORITIES. TODAY ~~HE~~ *Crozier* TOLD BY INSURANCE COMPANY THAT UNEXPECTED SERIOUS PROBLEM HAD ARISEN. DUE FACT OCCUPANT OTHER CAR SUFFERED SLIGHT HEAD INJURY WHICH WILL CAUSE SMALL SCAR LOCAL LAW REQUIRES COURT TRIAL. LAWYER CAN CLEAR RECORD BY BRIBES AND HAVE CAR RELEASED 22 JAN BUT WILL COST 400 DOLLARS U.S. WHICH ~~HE~~ *Crozier* DOES NOT HAVE.

2. REQUEST HQS PERMISSION FOR REASONS OPERATIONAL SECURITY GIVE ~~HE~~ *Crozier* 400 DOLLAR PSAS LOAN OR OPERATIONAL ADVANCE FOR ABOVE PURPOSE. REQUIRE REPLY NOT LATER COB 21 JAN DUE 1000 HOUR 22 JAN LEGAL DEADLINE.

3. FULL REPORT ACCIDENT PREPARED BUT AWAITING RELEASE CAR TO DETERMINE COST REPAIR WHICH PROBABLY ABOUT 800 DOLLARS U.S. WILL POUCH REPORT WHEN ESTIMATE IN. IF COST THIS HIGH STATION RECOMMENDS CAR BE DISPOSED OF RATHER THAN REPAIRED.
