1. SENSITIVE SYMPATHIZER SOURCE INDICATES THAT ON 3 OCTOBER WILLEM OLTMANS MADE APPOINTMENT MEET WITH CUBAN AMBASSADOR, THE HAGUE. OLTMANS STATED HE GOING "TO AMERICA ON 18TH" AND THAT HE " IS INDEED PREPARED TO GO AT THE BEGINNING OF NOVEMBER AS ARRANGED".

2. DURING DISCUSSION, OLTMANS SAID HE ALSO HAD VISIT SCHEDULED WITH RUSSIAN AMBASSADOR ROMANDV FOR 3 OCTOBER AND WANTED COMBINE TWO VISITS FOR SAME DAY.
