1. REQUEST ADDITIONAL INFO RE MRR MEMBERSHIP AND PLANS ESPECIALLY DETAILS ON RADIO BROADCASTS.
2. SUGGEST STATION CONTACT ARTIME AND ENCOURAGE MRR FORMATION UNDER MODERATE LEADERSHIP EXCLUDING KNOWN BAPTISTAS. MRR SUPPORT LEGITIMATE REPORTS ORIGINALLY MISLEADING BY REVOLUTION AT LEAST CONCERN THEM BY CASTRO REGIME.
3. STATION MAY OFFER GUIDANCE BUT AVOID FINANCIAL COMMITMENTS UNTIL PLANS AND OBJECTIVES KNOWN. IF GROUP RESPONDS TO GUIDANCE AND SHOWS WILLINGNESS COOPERATE WITH OTHER MODERATE ELEMENTS MRR PROBABLY WILL DESIRE GIVE SOME FINANCIAL ASSISTANCE.
4. DIAZ LANZ COLLABORATION NOT OBJECTIONABLE BUT REPORTS NOT ENCOURAGED.
5. RADIO BROADCASTS AND OTHER PROPAGANDA SHOULD WARN OF RISKS OF ASSOCIATIONS SUCH AS PARA 3 REF MANIFESTO.
