- PERRAPS TWICKER AND OTHERS CAN PERSUADE AMBIDDY TAKE WAIT AND SEE POSITIVE IN LIGHT PUBLISHED REPORTS ESCAMERAY DIFFICULTIES.

\*\* Hqs agreed in principle to infil but felt time not right and would be too much of security risk.
