1. VIEW AP ACCOUNT OF ANGUD MINISTERIAL APPOINTMENTS WHICH DESCRIBES ANGUD AS HEAD OF "INVADING ARMY" REQUEST YOU IMPRESS UPON ALL WAVE PRESS CONTACTS NEED TO ELIMINATE "INVASION" OR SIMILAR FROM UTTERANCES OR ISSUANCES.
2. PRESUME THIS UNFORTUNATE RELEASE DERIVES FROM WITHIN ANCIOB.
3. PVI: ANGUD-ONE IS NAMING A SPOKESMAN WHO WILL ACT FOR HIM AND ANGUD IN SAME WAY AS BLASIKHER ACTS FOR PRESIDENT. HQS WILL BE IN CONTACT THIS YET UNNAMED SPOKESMAN WHO WILL IN TURN MAKE HIS RELEASES VIA LEM JONES CBO WHICH HAS BEEN SELECTED BY ANGUD AS THEIR SOLE LIAISON WITH THE PRESS. UNDERSTAND OSBORNE OF MAC LARRY, ADDED AND OSBORNE INVOLVED IN "ACCREDITING" CORRESPONDENTS TO GO TO CUBA. THIS IS OF COURSE HIGHLY UNDESIRABLE, AND WE ASSUME THAT OSBORNE CBO BEING USED GULLIBALLY BY ANGUD-ONE TO ENHANCE LATTER IN PUBLIC EYE. LEM JONES WILL TELL OSBORNE THAT JONES CBO ONLY ONE AUTHORIZED BY ANGUD REPRESENT ITS INTERESTS, AND HEPY THIS WORD CAN BE SPREAD.
