1. FOLLOWING IS PERTINENT DATA ON TWO AMBIDY MEN WHO WERE DETAINED BY IANS UPON ARRIVAL MIAM:

- A. FRANK SANTIAGO BERNARDINO Y BABOT. DOB 11 DEC 1937 CUBA. CUBAN PP NUMBER 37362 ISSUED 26 NOV 1959.
- B. RAFAEL AUERLIO CIPRIANO QUINTERO Y ISALEA. DOB 10 SEPT 1942 CUBA. CUBAN PP NUMBER 38414 ISSUED 5 NOV 1959.

2. BOTH SUBJECTS ARRIVED MIAMI VIA GUEST AIRWAYS 3 MAY 1960. IANS DECLARED U.S. VISAS INVALID, AT HEARING 3 MAY BERNARDINO WAS EXCLUDED AND PAROLED. THIS ROUTINE. HIS STATUS PRECISELY THAT OF MANY OTHER EXILES HERE. LEARNED FROM AHRENS THAT QUINTERO UNFORTUNATELY FELL INTO HANDS OF LAWYERS WHO HAUNT IANS BUILDING LOOKING FOR CLIENTS AND HIS HEARING WAS POSTPONED BECAUSE OF LAWYERS ILLNESS. ALSO SHOULD BE REMEMBERED THAT REGARDLESS OF DOCUMENTATION: IF I&NS ESTABLISHES THAT ANY CUBAN ENTERING U.S. IS IN FACT POLITICAL EXILE HIS VISA IS CANCELLED AND PP TAKEN AWAY. IT THEREFORE NECESSARY INFORM I&NS OF EACH SP CASE PRIOR TO ENTRY SO AS AVOID INCIDENTS THIS KIND.
