

9. Superiors: degree of intimacy. According to L-9, AZCUE was called in about Sept 66 by Osmani CIENGUEGOS and almost fired from his job. Celia SANCHEZ was also critical of AZCUE. AZCUE who had been given the responsibility of the Pavillion at the EXPO 67 in Montreal had apparently failed miserably in fulfilling his job. CIENFUEGOS, who considered the the EXPO 67 affair a very very important event told AZCUE he Exhaudizates and done nothing. AZCUE was at the point of being fired when he produced a letter he had written to a government organization which asked for assistance and it had not been forthcoming. This letter apparently "saved" AZCUE from being summarily fixed from his post but it did not stop CIENFUEGOS from relieving AZCUE of his responsibilities re EXPO 67. This run-in with CIENFUEGOS has made AZCUE

responsibilities re EXPO 67. This run-in with CIENFUEGOS has made AZCUE a very bitter man and he wants to get out of Cuba as soon as possible.

His product plans are to leave Cuba for Mexico around the end of the year.

AZCUE plans to use a bad vertebrae as "cover" to get to Mexico.

Intelligence Affiliation

Elens Garro de PAZ, Mexican writer reported that Victor GALAW, the pro-Cuban journalist, wold her that AZCUE was a Spanish Cuban who had fought for a while in the Spanish Civil War, at which time he was also, by his own admission, a French intelligence agent. Because of ill health, he left the war in Spain and went to Mexico, where he worked for a while for Mession Lazaro CARDENAS.

(Encl A-727 from Mexico, 9 January 66).

AZCUZ was involved in alleged espionage in Mexico for the Cuban Government in 1961. (DBF-97388, 19December 61).

When AZCUE was Cuban Consul in Mexico, he was the contact between the Cuban Embassy and student groups, especially student groups from Micaragua, Guatemala and the Dominican Republic who were in exile in Mexico and against whose governments the Cuban Embassy carried out a programme of propaganda and subversion. (OEL)-26587, 10 May 60).

 Lee Harvey Oswali was probably in contact with AZCUE during the period 28 September-30 October 1963 when the latter was Guban Consul. It is surmised that the reference in Mwald's 9 November letter to a person who had since been replaced must refer to AZCUE, who left Mexico for Guba on a permanent transfer on 18 November 1963, four days before the assassination. Reportedly, AZCUE told AMKNOB-1 on 13 August that he was expecting a friend to replace him in Mexico and that he was going to Guba to work for the Guban peasant housing program, WAVE-9457,21 Dec 63; XAAZ-22781,17 Sep 64.

G. Psychological Assessment

 - a. Appearance
 - Describe his personal appearance, in terms of over-all impression and attention to details. Is he well-groomed, neat, fussy, prissy, conventional, individualistic? Consider attention to and care of clothing; general grooming, including attention to hair, nails, general cleanliness, etc.

2) Describe his ordinary style of dress. Is it conventional for his culture, or extreme or unique? Is it usually appropriate or inappropriate for particular occasions? Is he fashionable, overconscious, or inattentive to his own dress?

3) Describe his customary surroundings (home, room, office, "shop," etc.). Are they neat, organized, tasteful, sloppy, inviting, business-like, offensive, "lived-in," stodgy?

b. Expressiveness

 How expressive is he? What kind of gestures, or facial mannerisms, or verbal expressions does he use characteristically? How frequently and spontaneously does he use them? Are they effective, habitual, contrived, natural, annoying?

2) Describe any characteristic signs of tension (fidgeting, leg crossing, finger drumning, nail biting, clothes brushing, toying with pipe or keys or other objects, picking at face, stroking arms or legs, foot tapping, etc). Note the circumstances or situations where these are likely to occur, and when they are likely to stop or to be noticeably absent.

3) Does he use profanity? What kind, when and how often? If not, what kind of expressions or mannerisms does he use, where others might use profanity to express emotion or emphasis?

4) Characterize his reference to sex. Consider frequency, occasion and quality or content of sex references. Are they smutty, mildly off-colored, ciever-scribisticated, hostile, matter-of-fact? What is his behavior toward, and attitude toward prostitutes? 5) Describe his eye movement patterns, and the circumstances associated with them. Does he tend to maintain direct eye contact when talking? Does he maintain eye contact, close his eyes, or look away while thinking, or reflecting, or reminiscing?

- c. Smoking, Prinking, and Eating.
 - Describe his smoking behavior: What he smokes, how frequently, and the circumstances which affect his rate or pattern of smoking.
 - 2) Describe his drinking behavior: what he likes, how much and how often he drinks under "ordinary circumstances" (and how he would define "ordinary circumstances"), what his normal drinking pattern and pace is, and how he ordinarily reacts or behaves when drinking heavily, or too much.

3) Describe his ordinary eating behavior: what are his typical food preferences? Does he have any pronounced dislikes? Does eating take on any special importance? Is he a faddist, a chronic dieter, a cautious or selective eater?

b) Indulgence: in his attitude toward eating, drinking and smoking, does he seem to be sensual and self indulgent? Is he a person of sharp, dominating appetites; or does he take these things as matters of course, to sustain life or to promote socializing; or does he tend to ignore them, or to minimize their importance?

d. Health and Stamina

What is his general state of health? What kinds of illnesses is he likely to have, and how often? Does he have characteristic, or favorite methods of treatment, or medication, or drugs?

3) What is the relation between his "health complaints" and his apparent "true state" of health? Is he a chronic complainer, or preoccupied with health and fitness? Is no normally aware of his "true" condition? Is he stoic, and likely to suffer silently even when complaints might be considered "reasonable?"

Describe his normal activity level. Is he physically active, or passive? Is he quick acting, or slow; "nervous;" easily fatigued; untiring; always on the go?

2. Skills

a. What specific skills or abilities does be possess? b. How do others characterize him? Is he regarded as outgoing, reserved, a lone wolf, warm, self conscious, cynical, depressed, critical, considerate, selfish, conforming, argumentative?

c. Describe his "physical contact" behavior, in typical social settings. Is he a tack-slapper, hand holder, shoulder draper? How much does he use or depend on physical contact or props, for communication and support? Is he a finger stabber, a shoulder puncher, an elbow grabber, a table leaner?

d. What especially strong opinions does he hold? How firm are his convictions on controversial issues?

- e. Where possible, describe his handling of the following situations, using illustrative anecdotes:
 - 1) Being introduced to a strange person.
 - 2) Deciding where and what to eat; or what to do for entertainment.
 - 3) Organizing his day's work.
- f. Give a summary estimate of his poise and self assurance.
- g. Give a summary evaluation of the judgement, discretion and maturity.

4. Family Orientation

a. Describe his relationship with his immediate family. What is the relative importance of his family vs. his job, or other activities: How much does he participate in family activities? Does he play with his children; take his wife to parties? Does he demonstrate affection? How and how freely? b. To what extent is he motivated by self interest; by family interest; by group, or team, or organizational loyalvice; by patriotism or ethnic or cultural identification; by humanitarianism, or religious, or political idealism?

c. What are his personal pursuits and sources of satisfaction?
