AN AIR STRIKE AGAINST THE CITY OF HABANA FOR 16 FEBRUARY IN A B-25.
AN AMERICAN PILOT WAS TO FLY THE AIRCRAFT BUT WAS TO BE ACCOMPANIED
BY A CUBAN PILOT.) THE CUBAN PILOT HAS BEEN TRAINING IN THE B-25.

- 2. THE CUBAN PILOT IS THE SAME PERSON WHO WAS TO MAKE A BOSCH-FINANCED RAID IN A SINGLE-ENGINE AIRCRAFT AGAINST AN UNSPECIFIED TARGET. THE PLANE WAS TO LEAVE FROM THE KEY WEST AREA.
- 3. FIORINI SAID THAT BILL JOHNSON, AN AMERICAN PILOT WHO HAS BEEN ARRANGING THE SUPPORT ASPECTS FOR BOSCH'S RAIDS, RECEIVED AN UNIDENTIFIED SUM OF MONEY FROM BOSCH ON 17 FEBRUARY.
- 4. ACCORDING TO FIORINI, IF THE RAID HAD NOT TAKEN PLACE ALREADY, IT WOULD PROBABLY BE MADE WITHIN 24 HOURS.
- 5. FIELD DISSEM: CINCLANT, CINCSO, COMKWESTFOR, MIAMI REPS OF STATE, FBI, BORDER PATROL, CUSTOMS, I&NS, AND USCG.
