ANCIATIER-L

1. AMCLATER-1 has written me that there is at present in Mismi a men representing a high-ranking Castro officer who is involved in some way with the invasion prisoners. This unmamed representative has proposed to rescue a group of prisoners and deliver them to an embassy at a price of \$40,000 per head. ACLATER reports further that a number of Cuben fathers in Mismi are prepared to pay this amount to rescue four of their soms. The somey would be deposited in excrew with a reliable Cuben (Tito Mesa) who is to turn it ower only after the POW's have left Cuba. It is understood that Artime, Oliva and Gan Roman could be included in the deal which will not be possible once these prisoners are transferred to the Ile of Pines.

2. I want to make it clear that AMCIATTER-1 contacted me only as a last resort. Evidently he is no longer being "case officered" but is being handled administratively by _______ In view of AMCIATTER-1's past service and his continuing potential, my personal view is that since he is there he should be used and I sm going to suggest that PW pick him up.
