THIS IS UNEVALUATED INFORMATION. SOURCE GRADINGS ARE DEFINITIVE. APPRAISAL OF CONTENT IS TENTATIVE.

SOURCE A TRAINED OBSERVER WITH ACCESS TO A WIDE VARIETY OF CUBAN EXILES, SOURCE IS KNOWN TO MOST OF HIS CONTACTS AS A CHANNEL TO U.S. INTELLIGENCE, FROM BILL JOHNSON.

1. ( FIELD COMMENT: IT WAS PREVIOUSLY REPORTED THAT CUBAN EXILES MAY BE PLANNING AN AIR STRIKE AGAINST A MIG BASE IN CUBA. THE STRIKE WAS TO INVOLVE TWO ROCKET ARMED P-51 AIRCRAFT, WHICH WERE TO STAGE FROM AN AIRFIELD IN GEORGIA WHICH WAS USED BY AGRICULTURE FUMIGATION AIRCRAFT.)

2. TWO P-51 AIRCRAFT ARE BEING SOLD FOR THE TOTAL SUM OF 16,000 DOLLARS TO BILL JOHNSON BY THE AERO ENTERPRISES, INC. OF LA PORTE INDIANA. THE SHIPS HAVE NO EQUIPMENT AND ARE NOT ARMED.
