j. ITT: Attachment E contains what we consider to be all the data on DCD/ITT relationships relevant to the inquiry.

k. Robert R. Mullen and Company: Attachment F is two requests (1961 and 1969) for D&B reports on the company. Both probably were levied by Corporate Cover Branch.

l. Howard Hughes: DCD has had close and continuing relationships with the [redacted] 29 and the [redacted] since 1948. Both companies have been completely cooperative and have provided a wealth of information over the years. A careful review of the files on these companies disclosed no information which the reviewer considered to fall within the scope of this inquiry. It should be noted, however, that in the case of [redacted] 29, DCD has contacted over 250 individuals in the company since the start of our association and [redacted] 29 about 100 in [redacted] over the same period. The substance of the contacts ranged from FPI collection to sensitive operational proposals. In addition, there is some evidence in DCD files that both companies may have had contractual relationships with the Agency. In the context of such a broad [redacted] 29 range in [redacted] CIA relationships, it is difficult to state with certainty that the surfacing of the substance of a given action would not cause Congressional and/or media interest.
