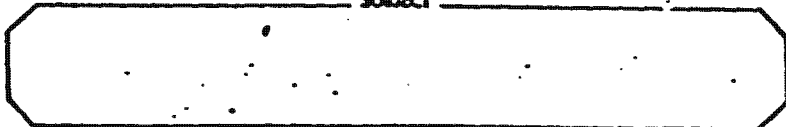

1. ON 17 MARCH 1966 FRANCISCO CALZADILLA NUNEZ, CUBAN CHARGE
D'AFFAIRES IN MADRID, WAS CONSIDERING LOGGING A PROTEST WITH THE
SPANISH GOVERNMENT AS A RESULT OF PLOTTING IN MADRID BY THE ARTIME
GROUP TO ASSASSINATE FIDEL CASTRO, AS DISCLOSED BY THE RECENT TRIAL
IN HAVANA OF COMANDANTE ROLANDO CUBELA SECADES AND HIS FOLLOWERS.
CALZADILLA WAS AWAITING INSTRUCTIONS FROM HIS GOVERNMENT AS TO THE
COURSE OF ACTION TO BE FOLLOWED.

2. INASMUCH AS THE DIRECCION GENERAL DE SEGURIDAD (DGS- DIRECTORATE GENERAL OF SECURITY) IN SPAIN SUSPECTED THAT THE CUBAN GOVERNMENT MIGHT SUBMIT A PROTEST, IT DETAINED JORGE ROBRENO MARIEGES FOR A SHORT PERIOD OF TIME SO THAT IT COULD BE IN A POSITION TO DEMONSTRATE THAT SOME ACTION WAS TAKEN AS A RESULT OF INFORMATION RELEASED DURING THE CUBELA TRIAL. (FIELD COMMENT: ROBRENO IS ONE OF THE PERSONS PRESENTLY IN SPAIN ALLEGED TO HAVE BEEN INVOLVED IN THE RECENT CONSPIRACY TO ASSASSINATE CASTRO.)

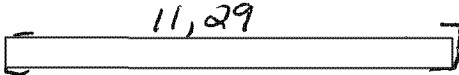
