1. In Jan 63, A-1 gave his case officer a report on one of Frank FIORINI's forays into Cuba. - No other details given. (UFG-2311)

2. In Feb 63, A-1 reported on a coaching op into Cuba by FIORINI - no further detail - WAVE 5400.  
(UFGA-8072, 13 Mar 63)

3. In Apr 63, A-1 reported info re an exile raid on Cuba. The info came from FIORINI. Per the SUPDATA on the intel cable, FIORINI knew that when he gave info to A-1 it would reach CIA.

4. A-1 provided info re FIORINI raid: in June 63. a info re planned DIAZ Lang raid. This info from FIORINI in Jul 63.

1. Angel Miguel Estevez Nunez introduced May 63 to AMCLATER-1 by "Julito" Garcesan as underground leader of JUVENTUD ANTICOMUNISTA REVOLUCIONARIA, a Garcesan affiliate. Estevez submitted several reports marginal interest which he claimed have received from Hector Alfonso AMA Fabian in asylum Uruguayan Embassy Havana. (Alfonso went Spain after being refused U.S. visa with other Uruguayan asylees.)

2. Basis his claim wide knowledge Cuban underground personal and their activities, Estevez use considered by RM but he found wanting in amenability to control. He occasionally contacts A-1 but not considered active source.
