B. HAS LONG RECORD PASSING BAD CHECKS. CONVICTED TWICE IN FEDERAL COURTS VIOLATION NEUTRALITY ACT AND THEFT GOVT PROPERTY IN ATTEMPTING SEND TWO PLANES TO ABOLIST IN REVOLUTION AGAINST VENEZUELAN GOVT.

C. IN MARCH 53 ATTEMPTED OBTAIN U.S. \$25,000 FROM PRESIDENT BATISTA FOR REVEALING CACHE OF ARMS.

D. SERVED TIME IN FEDERAL PENITENTIARY.

E. UNDER NAME EDWARD SAGATINO OBTAINED RESERVATIONS HOTEL MONTE CASSINO, MEXICO D F, ON APPROXIMATELY 6 MAY BUT USES ADDRESS ONLY TO RECEIVE MAIL. LAST APPEARED TO COLLECT MAIL 20 MAY. SINCE THEN TELEGRAM HAD ARRIVED DATED 20 MAY FROM MANAGUA, NICARAGUA, TO EDWARD BROWDER SAGATINO IN SPANISH "THE AMBASSADOR"
