FIELD REPORT NO.

1. ON 24 AUGUST 1964 ROGELIO CISNEROS SAID THAT HE HAD ADVISED ALL DELEGATIONS OF THE JUNTA REVOLUCIONARIA CUBANA (JURE, CUBAN REVOLUTIONARY JUNTA) OF HIS RESIGNATION FROM JURE. CISNEROS WAS RELUCTANT TO DISCUSS THE DETAILS OF HIS RESIGNATION AT THIS TIME; HOWEVER, HE SAID THAT MANUEL RAY, JURE'S LEADER, IS NOT CAPABLE OF CONDUCTING BOTH A MILITARY AND POLITICAL STRUGGLE AGAINST FIDEL CASTRO. CISNEROS BELIEVES THAT THESE TWO ELEMENTS ARE ESSENTIAL IN ORDER TO ACHIEVE SUCCESS.
