1. ROGELIO CISNEROS ARRIVED MANA FROM TEGU 27 APR VIA TACA 773 AND ENTERED COUNTRY WITHOUT DIFFICULTIES. HIS LATER DETENTION ON 30 APR NOT CONNECTED JURE OR EXILE POLITICS, BUT ON CHARGE FRAUDULENT APPLICATION FOR NIC PASSPORT. HE PURPORTED TO BE NIC CITIZEN BORN MATAGALPA 30 MARCH 1927 ON APPLICATION FORM. ERYTHROID-12 TURNED OVER COPY OF APPLICATION AND PHOTO TO [] AND SAID CISNEROS HAD SENT IT IN THROUGH TRAVEL AGENCY HOPING IT WOULD NOT ATTRACT ATTENTION. WHEN QUESTIONED BY E-12, CISNEROS STATED HE KNEW IT ILLEGAL BUT WOULD BE MORE CONVENIENT TO TRAVEL ON NIC PASSPORT THAN WITH OLD CUBAN PASSPORT AND CONSTANT BOTHER KEEPING UP US RESIDENCY, REENTRY PERMITS, ETC.

2. E-12 SAID CISNEROS GIVEN CHOICE LEAVING COUNTRY OR STANDING TRIAL. HE CHOSE TO LEAVE AND DEPARTED 2 MAY FOR PANAMA.
