1. WILLIAM BOWLER (WHITE HOUSE STAFF) HAS ASKED FOR DISCREET CHECK WITH ERYTHROID-1 AS TO WHY ROGELIO CISNEROS, CUBAN, WAS DETAINED IN MANAGUA RECENTLY. BOWLER, WHO IS FRIEND OF CISNEROS, BELIEVES CISNEROS HAS NOT BEEN CONNECTED WITH POLITICS SINCE 1961. CISNEROS IS PRESENTLY CARIBBEAN REP MIAMI, FLORIDA, FOR ENGINEERING FIRM OF POST, BUCKLEY, MOONEY AND SCRUH AND TRAVELS THROUGHOUT CA DEVELOPING BUSINESS FOR THIS FIRM; HE MAY HAVE AS BUSINESS ASSOCIATE IN MANAGUA ONE RODRIGO REYES.
2. CISNEROS WAS AT ONE TIME CONNECTED WITH JURE. PERHAPS THIS HAS SOME BEARING ON ~~REYES~~ BEING DETAINED. IF ABOVE REQUEST POSES NO SECURITY PROBLEM WOULD APPRECIATE ANSWER NEXT TWO DAYS.
3. NO IDENTIFIABLE HAS TRACES ON REYES; NO BEBOG ON CISNEROS.
