1- Conte met with Miro for three hours. Miro ratified that he wanted Conte to join the council and proposed no conditions. Neither did Conte. Miro sched Conte to answer him on Friday Sept. 22.

Hiro also told Conte that an "American" was coming down to Miami to take charge of all affairs here and that he would work in those contact with him (Miro). He also tald Conte take that the power of the Key Vest station would be increased and that directional antenns tould be installed. He (Miro) wanted Conte to address the Cuben recole over that station. He also said that he was getting full backing (from Amer. Govt.) in all matters and that he (Miro) would be in full charge of all military and propagands matters.

Miro told Conte that he had asked the following to form part of the council:
Directorio Estudiantil Revolucionario.
Frente Obrero ,FURDS (they must appoint three from which he willchose one)
Che professioanl man (not maned)
Hino Diaz
George Sotus
Conte

- 2- Conte told me that if he gets backing from the Govt. for him and his group he will not join the council. If he does not get backing then maybe he will join after all (he hasn't made up his mind.) By backing he means military and eccamic, for his group which is called Frente Anticomunista Cristiano. This seems to have been promised by XXXIIX Martin
- 3- Has the Uruguay book been printed yet? The name of the book is, "Alianza de la Libertad", and was entrusted to Alfredo Ferez Lagrave in Uruguay. 10,000 books were supposed to be printed but as yet he has heard nothing on this natter.
- 4- Miami book, "imerica Contra el Comunismo", 10,000 are being printed and markitatexfixiateta should be finished within ten days. He was given \$2000.00 but is still owed \$1000.00.
- 5- Conte is worried about income tax on the \$3000.00 he is getting for his in TRUL program and wants to know what to do about it. (what he really wants is to get out of paying it.)
