SUBJECT : Transmittal of Cuban Passports for Luis CONTE Aglero

1. Transmitted herewith is the new Cuban Passport #06609 requested for CONTE Aglero with an issuance date of 24 March 1959. This passport is complete, except for signature of the bearer at the bottom of page 3. The style of fill-in of the new passport is based on 1959 exemplars.

2. Per telephone discussion, the bearer should claim that his old passport was misplaced about March 1959, therefore, he made application for and was issued this new one. He never used this new passport as the Cuban government provided him with a Diplomatic passport in April 1959 for official travel, and in the meantime he found his old, but still valid, ordinary passport (containing valid U.S. visa). As soon as he resumed his unofficial trips, he used his old passport.

3. It is suggested that I&NS be briefed on why CONTE has the new 1959 issued passport before travel is attempted.

4. Also returned herewith is the old passport #27449 which is no longer valid. It does contain valid visas, thus should be carried by CONTE, along with the new passport, on his next trip outside the U.S.

5. Please sign and return one copy of the enclosed receipt for authentication materials.
