1. WESSIN SITUATION FIRST CAME JMWAVE ATTENTION NIGHT 9 SEPT VIA URGENT TELECOM FROM AMCORE-2 WHO PLANNED 9 SEPT BROADCAST IN SUPPORT "WESSIN GOVT" WHICH CONGEN ARVELO CLAIMED WAS TAKING OVER DOMREP AT ANY MOMENT. CASE OFFICER MANAGED RESTRAIN AMCORE-2'S FREEWHEELING AND A-2 MADE NO REFERENCE WESSIN ON BROADCAST. AFTER PRESS REPORTS WESSIN BEING ASSIGNED MIAMI REACHED JMWAVE 10 SEPT, CASE OFFICER MET A-2 AND BRIEFED HIM ON ODIORE POLICY OBJECTIVES DOMREP FOLLOWED BY DETAILED INSTRUCTIONS PER REFS A AND B IN NIGHT MEETING 10 SEPT PRIOR TO ARRIVAL WESSIN AIRCRAFT. A-2 AGREED COOPERATE FULLY. STATION ALSO ALERTED AMCARBON-1 AND AMYRIC-1 TO TRY GET FRIENDLY PRESS COVERAGE WESSIN ARRIVAL AND PREVENT PRESS INTERVIEW IF HELD. NEWS OF ARRIVAL HAD ALREADY SPREAD VIA ARVELO AND NEWSMEN FROM AP, UPI, TIME-LIFE, DIARIO LAS AMERICAS WERE AT AIRPORT WHEN WESSIN ARRIVED. STATION ALERTED JOHN BARFIELD OF STATE DEPT

RECEPTION CENTER GIVE AMCORE-2 PRIOR CRACK AT VESSIN IF POSSIBLE, AND A-2 WAS ABLE TO REACH VESSIN FIRST AND WHISK HIM THROUGH PRESS CROWD. EXCEPT FOR FEW BRIEF COMMENTS TO NEWSMEN A-2 SUCCESSFULLY GOT VESSIN'S COOPERATION MAKE NO PRESS STATEMENT.

2. IN A-2'S CAR VESSIN CRIED OPENLY, BITTERLY COMPLAINING THAT HE LEFT DOMREP ONLY WITH SUIT ON HIS BACK AND HAD NOT BEEN ALLOWED CONTACT HIS FAMILY WHOM HE WAS CONCERNED MIGHT BECOME OBJECT REVENGE BY REBELS, AND THAT HE HAD VIRTUALLY BEEN HELD PRISONER SINCE HE LEFT DOMREP. A-2 POINTED OUT VESSIN HAD BROUGHT THIS ON HIMSELF BY ACTIONS THAT THREATENED DESTROY GAS AGREEMENT, BUT THAT THIS WAS ALL WATER UNDER BRIDGE NOW AND VESSIN SHOULD LOOK TO FUTURE AS STATESMAN AND SOLDIER WHOSE CHIEF INTEREST PATRIOTIC RESOLUTION HIS COUNTRY'S CRISIS. A-2 CONTINUED WITH EMOTIONAL SPEECH AND PROMISED VESSIN HE WOULD DO ALL WITHIN HIS POWER TO PUT HIM IN TOUCH WITH HIS FAMILY, AND ALSO TO CLARIFY (THROUGH GAS CONTACTS) HIS APPOINTMENT AS CONSUL GENERAL WHICH HAD NOT YET BEEN RECEIVED MIAMI.

3. ARVELO INVITED VESSIN STAY OVERNIGHT AT CONSULATE BUT VESSIN DECIDED SPEND NIGHT WITH LONGTIME FRIEND ANTONIO LLANO MONTES, CUBAN NEWSMAN WHO KNEW VESSIN FROM DOMREP. BEFORE REACHING LLANO HOME, A-2 OBTAINED AGREEMENT FROM VESSIN TO ISSUE PRESS RELEASE TO

BE WRITTEN BY A-2, COVERING POINTS SUMMARIZED BELOW:

- A. VESSIN ACCEPTS PRESENT POSITION AS PERSONAL SACRIFICE BEHALF HIS PEOPLE AND COUNTRY.
 - B. REBEL FORCES NO LONGER CAN USE VESSIN PRESENCE AS EXCUSE NOT TURN IN ARMS.
 - C. DOYREP ARMED FORCES WILL CONTINUE SERVE COUNTRY AS INSTRUMENT LAW AND ORDER.
 - D. PRESENCE MIAMI WILL KEEP VESSIN CLOSE TO CASTRO COMMUNIST THREAT, HE WELCOMES OPPORTUNITY CONTINUE FIGHT AGAINST COMMUNISM AND CALLS UPON WESTERN HEMISPHERE FIGHT COMMUNIST THREAT ON ALL FRONTS.
 - E. FORTHCOMING MONTHS ARE CRUCIAL TO DEVELOPMENT AND ELIMINATION COMMUNIST THREAT TO DOYREP. VESSIN WILL DO ALL WITHIN HIS POWER HELP ENSURE FATHERLAND EMERGES TRIUMPHANTLY FROM CRISIS. HE IS PROUD OF ALL HE HAS DONE TO IMPEDE COMMUNIST TAKE OVER AND REITERATES DEDICATION TO CHRIST AND COUNTRY.
4. AS OF 1300 EST VESSIN STILL CONCERNED ABOUT SAFETY HIS FAMILY AND HAD NOT GIVEN FULL AGREEMENT TO TEXT ABOVE PRESS RELEASE.
- A-2 REPORTED HE HEARD BATTISTIANO'S HAD REACHED VESSIN THROUGH LLANO AT LATTER'S HOME MIDNIGHT HOURS 10 SEPT AND THAT WHEN TALKING WITH

A-2 MORNING 21 SEPT HE SEEMED MORE SELF ASSURED AND LESS WILLING
