1. HQS REQUESTING ANCORE-2 CONTRACT ON MONTHLY BASIS. REQUEST WAVE USE WIBALDA TO CONTROL A-2 AND REACH BROAD AGREEMENT CONTENT OF PROGRAM.
2. HQS AGREES ON REDUCTION A-2 PAYMENT FROM \$3000 to \$2500 MONTHLY. PAYMENT IS MADE BY WREIL TO A-2 ON THIRTEENTH OF EACH MONTH. WAVE WILL ADVISE HQS WHEN AGREEMENT HAS BEEN REACHED WITH A-2 AND WHEN REDUCED PAY EFFECTIVE.
3. AS CHECK ON A-2 PROGRAM CONTENT REQUEST WIBALDA GET TAPES OF BROADCASTS FROM WAVE IF AVAILABLE. IF NOT HQS CAN GET FROM WREIL AT COST OF \$10 PER DAY.
