1. AFTER SEVERAL MEETINGS BETWEEN AMCORE-2 AND IDEN, FORMER DROPPED ALL EFFORTS CONTACT HIGHEST OFFICIALS US GOVT, ~~SECRETARY OF DEFENSE~~, AND AGREED BOARD PLANE FOR RETURN WAVE 3 SEPT. A-2 DRIVEN TO AIRPORT AND AWAITING PASSAGE STAND-BY BASIS. A-2 ENTIRELY COOPERATIVE AND AMENABLE TO FOLLOWING DIRECTION FROM HIS CASE OFFICER WAVE.
