2. ANDIP-1 SAID NO CODES IN TAKE WHICH, APART FROM ABOVE DOC, CONSISTS ONLY CITIZENSHIP REGISTRY AND VALUELESS ADMIN DOCS.
3. DR. LLACA SHOWED PARA ONE DOCS TO PERU PRESIDENT AND FONKIN, TO CHILE PRESIDENT AND COLOMBIAN FONKIN.
4. UPI STORY DATED SANTIAGO, CHILE, 28 SEPT DESCRIBES ANTI-CASTRO ACCUSATIONS BY DIP. VALDES LARRAIN BASED PRESUMABLY ON CONTENTS. STORY RE THESE DOCUMENTS APPEARS IN ISSUE 29 AVANCE.
