MEMORANDUM FOR THE RECORD

SUBJECT: Conversation with Reichhardt, 4 September

1. I phoned Reichhardt in the afternoon and caught him at his office. He told me that he had talked with Bill FAWLEY on the phone and will lunch with him next week.

2. I told him that the cryptonym he had asked for in his USV-4-4 is ANCHUTTER.

3. I told Reichhardt that we had consulted with State and Immigration and that they have no objection to getting a visa for the wife of Marcos DIAZ and the kids. I gave him the plans that [redacted] will have her apply for an immigration visa and will provide an address to which an affidavit of support can be mailed. Reichhardt is to obtain an affidavit of support from [redacted] or OS [redacted] together with acceptable proof of a capacity to provide that support. Reichhardt will check with AHELES, the District Director of Immigration, for details on how this must be made out. I will phone him the address as soon as I get it from [redacted] 16-3
Meanwhile Reichhardt is to see AHELES and arrange to have Marcos DIAZ processed in true name. This is being done at the request of the OS/Alien Affairs Section, since paroling Marcos in pseudo was a mistake, and INS would like to get that cleared up. There has been a change in the head of the intelligence set-up at INS and the new guy is somewhat unsure of his ground so that OS/AAS is trying to make a few points with him. Clearing up the Marcos affair will aid in this.

4. I told Reichhardt we had received a letter from Carlos CHESMAN to the effect that Mario SANDOVAL will be in Miami at the end of the month and that both Carlos and Mario want to come to Washington for discussions. I gave Bernie Carios' address, told him to contact Carios, and to arrange to talk with Mario in Miami so that they would not have to come to Washington.

5. I gave Reichhardt the gist of HAVA 2616 (IN 21335) which says that Jose TAJUECHEL of Santiago, Cuba, and a trusted source, sent Angel ROS to talk with a couple of Station officers in Havana. ROS said he is a member of the DIAZ LANS organization and that the group presently plans nothing but consolidation. ROS asked for help in setting up a secure channel of communication with Ricardo DE LA LORIE in Miami. ROS was to go to Miami about 1 September.

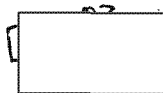

to see LORIE. Reichhardt had no information on a visitor arriving to see the DIAZ boys and LORIE. I explained that we had authorized Havana to use a cut-out for forwarding letters to LORIE from RGS, and would send him the details.

6. Reichhardt was anxious for us to get Mrs. DIAZ to the U.S. because Marcos is pressing him hard and says she is ill from an ulcer.
