1. ZAMKA TALKED TO WIFE OF MARCOS DIAZ LANZ NIGHT 27 JULY AND BRIEFED HER NOT REVEAL TO ANY ONE HIS ACTUAL DEPARTURE CUBA OR HIS PRESENT WHEREABOUTS. INSTRUCTED HER TO START OBTAINING NECESSARY DOCS SO SHE AND CHILDREN COULD OVERTLY LEAVE CUBA FOR MEXI. SHE AGREED AND FORESAW NO IMMEDIATE PROBLEMS. HQS AND [] WILL BE KEPT ADVISED.
2. ONLY MESSAGE SHE HAD FOR PASSING MARCOS WAS SHE EXTREMELY RELIEVED HE SAFE AND FOR HIM NOT TO WORRY RE HER SITUATION. ALSO TO TELL HIM HIS FATHER AND MOTHER, INCLUDING HERSELF, SAFE AND HAVE NOT BEEN MOLESTED BY AUTHORITIES.
