FOLLOWING FROM GALBOWJ:

1. CONCUR VISA ASSISTANCE AND USE APPROXIMATELY 1,000 DOLLARS FOR TRAVEL AND SUBSISTENCE MARCOS DIAZ LANZ FAMILY DURING RESETTLEMENT.
2. REQUEST HQS ARRANGE WITH IMMIGRATION SERVICE TO PERMIT DIAZ BE TAKEN DIRECTLY TO WASHINGTON IMMEDIATELY AFTER ARRIVAL TAMPA AND COMPLETE IMMIGRATION FORMALITIES EITHER TAMPA OR WASHINGTON WITHOUT EXPOSING HIM SECURITY COMPLICATIONS INHERENT HIS TRAVEL MIAMI.
3. IF IMMIGRATION AGREES ABOVE, REQUEST OFFICE SECURITY PROVIDE ESCORT MEET KARNLEY TAMPA 26 JULY, ESCORT DIAZ TO WASHINGTON, AND PROVIDE SAFEHOUSE WHERE DIAZ CAN BE DEBRIEFED BY INTERESTED AGENCIES INTELLIGENCE COMMUNITY.
