GROUP WITH TRAILER AND CAR URUAPAN: JORGE RODRIGUEZ MACHADO (NO TRACES STATION) - POSSIBLY JORGE RODRIGUEZ SIERRA, ENIO LEIVA FUENTES, ORLANDO VENTURA REYES, AND MANUEL CARBONNEL DUQUE. GROUP AT "POSADA DEL SOL" APATZIHCAN FOLL: GUSTAVO ARCOS Y BERGNES, JOSE ALBERTO FERREIRA (PROBABLY JOSE ALBERTO SEMIDEY), EDMUNDO RODRIGUEZ LOPEZ, ARMANDO FRANCISCO MAYNAR (NO TRACES), ROBERTO SOLLET GUILLARDE, PEDRO RUIZ LANZ (PROBABLY PEDRO LUIS DIAZ LANZ), AND FRANK FIORINI. FIORINI NAMED CO-PILOT AND OWNER PLANE C-46 N 18-449. (FC: ON 18 NOV GRACIELA DE LA LORIE MIAMI TOLD SILVIO PENA THAT "CARRO DE PACO" BEING USED IN "ESE ASUNTO"(LIFEAT B-2)). (FC: THIS POSSIBLY REF USE PLANE IN ABOVE OP FIORINI WHO KNOWN AS "FRANCISCO" AMONG CUBANS.)
