2. A 5 ASKED ZAMKA WHETHER HE SHOULD JOIN GROUP SINCE DOOR LEFT OPEN FOR HIM. A 5 WAS INSTRUCTED TO STAY AWAY DUE POSSIBLE PROVOCATION ATTEMPT TO BRING HIM OUT IN OPEN.
