- 1. (FIELD COMMENT. THERE HAVE BEEN A SERIES OF ALLEGED PLOTS TO ASSASSINATE FIDEL CASTRO RUZ, PLANNED BY VARIOUS EMIGRES AND EMIGRE GROUPS IN NIAMI. A REPORT DATED 6 JANUARY 1966 FROM THE SAME SOURCE GAVE INFORMATION ON DIAZ! PLAN TO ASSASSINATE CASTRO.)
- 2. ON 4 MARCH 1966 HERMINIO DIAZ GARCIA SAID THAT HE AND THE UNNAMED MEMBERS OF HIS GROUP WOULD LEAVE MIAMI FOR CUBA "AT ANY MOMENT" TO ATTEMPT TO ASSASSINATE FIDEL CASTRO RUZ.
