 A CUBAN EXILE WITH EXCELLENT CONTACTS IN THE CUBAN EXILE COMMUNITY. HE HAS BEEN AN ACCURATE REPORTER ON GENERAL EXILE POLITICAL DEVELOPMENTS SINCE ABOUT MID-1962.

1. UNIDENTIFIED MEMBERS OF THE DOMINICAN REPUBLIC ARMED FORCES INFORMED A CUBAN EXILE RESIDENT OF MIAMI WHO WAS VISITING THE DOMINICAN REPUBLIC, THAT ON 25 MARCH 1965, ARMANDO FLEITES DIAZ, AND FIVE OTHER MEMBERS OF THE SEGUNDO FRENTE NACIONAL DEL ESCAMBRAY (SFNE, SECOND NATIONAL FRONT OF THE ESCAMBRAY), HAD DEPARTED FROM THEIR BASE IN THE DOMINICAN REPUBLIC FOR THE PURPOSE OF MAKING A COMMANDO ATTACK AGAINST CUBA. THE MEN WERE USING A "BERTRAM" BOAT AND PLANNED TO MAKE THE ATTACK AS SOON AS THE OPPORTUNITY PRESENTED ITSELF.
