HAS ADVISED ^{O2} [UNSNAFU/9] THAT KUBARK SALARY STOPPED EFFECTIVE 31 MAY. ^{O2} [UNSNAFU/9] HIMSELF ANTICIPATED SALARY CUT OFF SHORTLY AFTER BEING FIRED BY ^{O2} [UNSNAFU/9] SO ANTICIPATE NO REAL PROBLEMS THIS SCORE. HAS RECENTLY BECOME INCREASINGLY APPARENT THAT ^{O2} [UNSNAFU/9] MUCH INFLUENCED BY ANTI-KUBARK ATTITUDE OF AMLASH/3, ESPINOSA, AND KUBARK "NO ACTION" POLICY. FUTURE POTENTIAL THEREFORE APPEARS CONSIDERABLY REDUCED.
