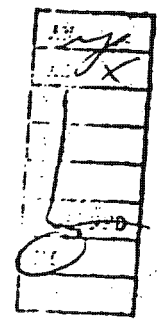

1. (THIS IS CABLE NO. 2 OF A SERIES OF THREE CABLES).
 FOLLOWING IS A SUMMARY FROM JMWAVE FILES OF WOFAC RELATIONS WITH THE INFORMATION COUNCIL OF THE AMERICAS (INCA). (AS FAR AS OUR FILES INDICATE, THERE WAS NO EARLIER RELATIONSHIP WITH THIS GROUP. STATION FILES DO NOT INDICATE WHEN INCA WAS ESTABLISHED. ORGANIZATIONAL IMPETUS AND FUNDS APPARENTLY COME FROM WEALTHY NEW ORLEANS FIGURES, INCLUDING DR. ALTON OCHSNER (OF THE OCHSNER CLINIC) AND WILLARD E. ROBERTSON. IN RECENT YEARS FUNDS HAVE BEEN SUPPLIED BY THE SCHICK SAFETY RAZOR CO. AN INCA LETTERHEAD WITH ALL OFFICERS AND DIRECTORS LISTED IS AVAILABLE IN JMWAVE FILES.)

2. IN JANUARY 1965 INCA SPONSORED AN APPEARANCE IN NEW ORLEANS OF JUANITA CASTRO. SALVADOR LEW WHO IS JUANITA CASTRO'S BUSINESS MANAGER WAS ALSO INVOLVED WITH THE INCA OFFICIALS IN THE PLANNING AND ARRANGEMENTS FOR

THE APPEARANCE. JUANITA CASTRO MADE A SPEECH AND WAS GIVEN AN AWARD BY INCA AT A DINNER SPONSORED BY THE GROUP AND ATTENDED BY CIVIC LEADERS AND PEP'S OF ALL NEWS MEDIA. THIS APPEARANCE OCCURED SOON AFTER THE ARRIVAL OF MISS CASTRO IN THE U.S. AND NOT LONG AFTER HER DEFECTION. THERE WAS A FLURRY OF ACTIVITY AND A LOT OF INTEREST IN HER AT THAT TIME AND INCA HAD A PARTICULAR INTEREST SINCE THEY DISTRIBUTED HUNDREDS OF TAPES IN BOTH ENGLISH AND SPANISH CONTAINING JUANITA CASTRO'S DECLARATIONS MADE AT THE TIME OF HER SURFACING IN MEXICO. (THIS IS A PART OF THE INCA "TRUTH TAPES" SERIES). THE AWARD WAS IN RECOGNITION OF THE VALUE OF THESE TAPES.

3. THE ONLY SUBSEQUENT CONTACT BETWEEN JMWAVE ASSETS AND INCA (BEYOND SOME CASUAL CORRESPONDENCE) HAS BEEN BETWEEN ⁰⁶ [REDACTED] AND EDWARD BUTLER, EXECUTIVE VICE-PRESIDENT (AND PRIME MOVER) OF INCA, WHEN THE LATTER WAS IN THE JMWAVE AREA RECENTLY PROMOTING THE INCA FILM ON ECASIRO - HITLER IN HAVANA. THE STATION HAS WANTED TO AVOID ANY MORE JUANITA CASTRO INVOLVEMENT WITH INCA BECAUSE OF ITS EXTREMIST POLITICAL ORIENTATION AND [REDACTED] SERVED

4. THE INCA OFFICIALS HAVE NEVER MADE ANY ALLEGATIONS CONCERNING WOFACT CONTROL OR GUIDANCE OF MISS CASTRO ²¹¹ [REDACTED] TO OUR KNOWLEDGE, ARE NOT AWARE OF WOFACT INVOLVEMENT WITH THEM. JMWAVE BELIEVES THAT NO INCA OFFICIALS HAVE HAD ANY OFFICIAL CONTACT WITH WOFACT OFFICERS. IT IS BELIEVED THAT HEADQUARTERS CAN BEST SUPPLY INFORMATION CONCERNING ANY TIES BETWEEN CFC AND INCA.
