*TWICKER comments re [redacted] 3878, who doubts authenticity report for several reasons; AMCIQAR members were not living in same house in Mexi; Sanchez Arango could not have been present at alleged meeting as Sanchez never in Mexi dur lack of visa. TWICKER theorizes report came from disgruntled informant who known to Mexi Station as soldier of fortune and bad type.
