 AUGUST. FOR MASH: UPON RECEIPT THIS MESSAGE, GUPTON SHOULD CHECK WITH ANPALM-5
 WHETHER APPLICATIONS MADE AND ADVISE.

2. AFTER AGREEMENT REACHED, AMANK MADE FORMAL STATEMENT THAT FRD BOWING
 TO UNILAY US. ISICH BUT WANTED POINT OUT ONCE AGAIN DANGERS FRD OPERATING
 MEXI: POLICE HARRASSMENT, POSSIBLE KIDNAPPING, SYSTEMS COVER PENETRATED OFFICIAL-
 DEM. DOWN FRD WERE UNAVOIDABLE AND BENDER SHOULD TAKE RESPONSIBILITY FOR THIS.
