1. HOGAN'S REPUTATION KNOWN TO YOU. DISCUSSING CASE WITH ODENVY BETS IN ATTEMPT SOLICIT THEIR HELP RESTRAINING HOGAN IF REF INFO CORRECT. FERNANDEZ ECHEVARRIA WILL BE APPROACHED BY ONE OF OUR CONTACTS IN ATTEMPT ASCERTAIN DETAILS MATTER AND PERSUADE HIM NOT TAKE ANY PRECIPITOUS STEPS. WILL KEEP YOU ADVISED OUTCOME THESE TWO APPROACHES.

2. IN INTERIM YOU CAN ADVISE AMPAIM FOUR THAT

A. HIS KUBARK CONNECTION KEPT MOST SECRET AND SECURE AS FAR WE INVOLVED. ALSO SO FAR NO INDICATION AMBIDY OR AMPAIM FIVE INDISCRETION THIS REGARD.

B. AMPAIM FOUR CONTINUED PRESRECE CUBA MOST IMPORTANT VIEW NEED PORCE UNIFIED CASTRO OPPOSITION AND ROLE AMPAIM FOUR CAN PLAY THIS REGARD. IT LIKELY AMRASP WILL HAVE THE ONLY REAL SIGNIFICANT POLITICAL MILITARY CONTRIBUTION TOWARD SOLUTION CASTRO PROBLEM. THUS ALL AMPAIM FOUR CAN DO TO HAVE PEOPLE RALLY AROUND AMRASP WILL BE FOR GOOD ALL CUBANS.
