Subject: AMDENIM/1

AMDENIM/1 was interviewed and tested on 11 April 1963 at a safe site in the Miami area. The interview was requested by Norman D. KIGGINS and it was conducted in the English language. KIGGINS monitored the major part of the interview. AMDENIM/1 has a POA and an GA has been requested.

A major purpose of the interview was to try to determine Subject's view of his relationship with KUBARK. The test itself covered foreign intelligence communism and the possibility of Subject's connection with any person or group which he was deliberately concealing from KUBARK.

RESULTS

AMDENIM/1 is not and has not been involved with any non ODYOKE intelligence service. He has not been involved in any communist activities. He does not have any connections with any persons or groups which he is deliberately concealing from KUBARK. Subject mentioned his involvement with the UNIDAD REVOLUCIONARIA and the COMANDO L-66 (CI-66).

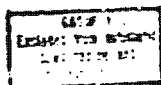
BACKGROUND

Subject has been in touch with KUBARK representatives since January 1959. Current KUBARK effort is directed toward attempting to assert a greater degree of control over Subject. The history of Subject's association with KUBARK has largely been a history of his attempt to assert his independence - not only KUBARK but also of any Cuban exile group he could not himself control. In the past, Subject has consistently refused to accept an LCPLUTTER. If the KUBARK files are an accurate representation of AMDENIM/1's motives, they portray a man dedicated to freeing Cuba - but on his own terms.

DETAILS

The examiner began the interview by asking Subject why he had so consistently objected to LCPLUTTER. In a rather rambling way Subject stated that he saw himself as an "ally" working with ODYOKE to bring about the end of Castro. He resisted any attempt to put him in a position where he would feel that he was an employee of KUBARK. He considered LCPLUTTER a symbol of the loss of his independence. The examiner then asked if Subject meant that he did not want to feel himself controlled. AMDENIM/1 objected to the use of the word "control", nevertheless what he was

saying amounted to the same thing. About this point, he castigated KUBARK's choice of agent personnel (many are making a better living going through the motions for KUBARK than they ever did before) and KUBARK's choice of Cuban leaders - ARTINE and the members of the CONSEIJO. In fact, throughout the entire interview, Subject contrasted his successes with the failures of other KUBARK directed efforts. He contrasted the pre-invasion first team case officers with the post invasion second team.

If the examiner is allowed to sum up the underlying, but never clearly expressed, frame of reference which Subject sees, it would be this: Prior to the invasion, KUBARK worked with the Cubans in an attempt to defeat Castro. Ever since the invasion, KUBARK has increasingly moved in the direction of using the Cubans for ends which are often clouded. In taking the LCF LUTTER Subject signaled his acceptance of the new order. He has apparently decided that without KUBARK aid, he can do nothing - although he is still not sure what can be done with it. He was willing to go on record by responding in the affirmative to the question asked on the test:

"Do you feel that KUBARK's handling of the Cuban situation has been inept?"

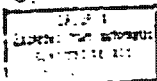
Was there an area, the examiner asked, in which Subject would not cooperate with KUBARK. For example, if he (AMDENIM/1) received information which he knew would be of interest to KUBARK, would he refrain from reporting it if he decided it was not in the best interests of the Cubans to do so. Subject ducked that question by stating that he would be careful not to find out something that he might have to report. He noted that most Cubans know of his relationship with KUBARK and they would refrain from telling him anything they did not want to reach KUBARK.

In addition to questions relating to foreign intelligence and communism Subject was asked:

Excepting the UK and CL-66, are you involved with any other political or revolutionary group?

Do you have a relationship with any person or group which you are deliberately concealing from KUBARK?

Have you used any KUBARK funds in any unauthorized manner? (This question meant had he used KUBARK funds for anything forbidden by KUBARK)

Have you had any knowledge of any unauthorized group's activities which you did not report to us?

Subject answered in the negative to all and there was no indication of deception.
