1. VIEW UNRESOLVED ASPECTS NOTED REF A AND KANTOR'S CONTINUED FRIENDLY RELATIONS SOVIETS AFTER HIS TURNDOWN OF PITCH, BELIEVE RAMEY SHOULD INTERROGATE FURTHER PRIOR DECIDING USE POLYGRAPH BASED STA AND RAMEY FINDINGS HCS WILL MAKE FINAL POLYGRAPH DECISION.

2. IN SPITE PLAUSIBILITY REFS HAVE RESERVATIONS RE BREAK OFF REGULAR CONTACTS IN FEB. KNOWLEDGE SOVIET NO INDICATES RELUCTANCE BREAK WITH "ASSETS" HAVING ANY POSSIBLE FUTURE UTILITY. SUBJECT, WITH CONTINUING FRIENDLY ATTITUDE, COULD HAVE SERVED AS WITTING OR UNWITTING AMERICAN STUDENT SPOTTER. BREAK OFF POSSIBLY EXPLAINED AS SECURITY PRECAUTION FOR RECRUITED AGENT WHOSE REF A DEBRIEFING REFLECTS SOVIET PLOY TO DEFLECT AIS INTEREST.
