

SUBJECT: AMUPAS-1

- 1. On Friday, 26 January 1962, Jane Roman (CI Staff Liaison Group) advised me that the Bureau wished to know the inhowing:
 - a. What is our relationship to AMUPAS-1 at this time?
 - b. Do we have any objection to the Bureau's advising the Department of Justice that AMUPAS-1 may be listed as a prospective witness in a forthcoming Department of Justice case? The Bureau added that it would assign a T number and would not otherwise identify here to the Department of Justice.
- 2. I advised Mrs. Roman that AMUPAS-1 is still an agent for WH Division. I further advised her that we would have no objection to the Department listing her as a prospective witness if it assigned her a T number and would not otherwise identify her to the Department of Justice. I raised a question concerning AMUPAS-1's fate on her return to the states, since we did not wish to destroy her operational potential. Mrs. Roman said that she would advise the Bureau of our continuing interest in AMUPAS-1 even if the latter returned to the states, and would get assurance from the Bureau that she would not be subpoenaed.
