KOLETTY, KNOWN TO YOU, WHO NOW FBIS TRANSLATOR STATIONED SAPPORO, HOKKAIDO, JAPAN. DURING LCFLUTTER DEBRIEFING KOLETTY IDENTIFIED PERIS AKA GEORGE PARIS, GREEK NATIONAL, BUSINESSMAN IN TOKYO AS CLOSE CONTACT.
