

- 1. On 1 December 1957, Rolando MARTERED, a Cuben senator who is noted for gangster-type activities, and Laureano the control of the total of the control of the total of the control of the regarding the reasons for the trip become so rampant that during the next week, it was impossible to severate truth from fiction. The true reason for their trip seems to be more along the following lines During the recent trouble in Santiago de Cuba, IBARPA, who is sometimes said to be the true government toss in town, became frightened of rebel reprisals, and he sand-begged his house and stationed an armed guard in front. of money from local money lenders, saying that the money was for "higher authorities", i.e., General alterto DEL RIO Chaviano, the militer; commander for Oriente Province. Then word of this dual action - the robberies and the extortion - reached DEL RIO, he became very angry and called in MADALINER and IP.ARLA and after chewing them out, forced them to return the money to the money lenders. On leaving the military barracks, MADALINER is said to have complained to PRARRA that it was impossible to conduct business with DEL RIO in charge of the area, and that serious thought should be given to "eliminating" him. Unfortunately for LASELERIE, it is said that this statement got back to DEL REO, and consequently, there wasn't any commercial eviation leaving mantie; o de Cuta fast enough, so they requisitioned the private plane and flow to Caracas.

3. As stated previously, it is quite difficult to separate fact from fiction on this natter, but this is probably the best account of the trip that the base has been able to find.
