2. AT A 30 JULY MEETING AT MORGAN'S HOUSE, SFNE OFFICERS DISCUSS-ED A STRATEGIC PLAN TO CUT CUBA IN HALF BY GAINING CONTROL OF LAS VILLAS PROVINCE.
