1. CLARED POLICE CONTACT ADVISED CLIFFORD V. CORNELL, AGE 38; HAROLD WHIDDLE, AGE 45; REXER ESTUS BLOW, AGE 36, ARRESTED WAVE AREA FOR THEFT 40 CASES DYNAMITE AND ILLEGAL POSSESSION EXPLOSIVES. CORNELL APPEARED JUSTICE PEACE COURT AND CLAIMED STOLE DYNAMITE FROM JOSEPH E. NICKOL, AGENT. CORNELL'S TRIAL DATE NOT SET BUT PLANS WAVE DEFENSE IN COURT FOR KUSODA.

2. NICKOL IS NOT KUBARK AGENT BUT USED SOLELY AS INFORMANT BY A-14M (SEE REF). WAVE HAD NO KNOWLEDGE CORNELL'S ACTIVITIES OR RELATIONS WITH NICKOL IF ANY. NICKOL WAS SUSPECT IN \$300,000 ROBBERY AND UNDER SURVEILLANCE BY COMNAV.

3. KUSODA ACCEPTED TO CORNELL'S PLAN FOR DEFENSE. KUSODA ADVISED LOCAL POLICE CONTACT NICKOL IS NOT KUBARK BUT COVERT INFORMANT. HOWEVER, DUE TO KUBARK POLICY, KUBARK CANNOT ADMIT OR DENY CORNELL'S CLAIM OF ANY RELATIONS WITH NICKOL. POLICE CONTACT UNDERSTANDS KUBARK POSITION AND ASSURED NICKOL THERE COULD BE NO
