1. IDEN REF MET HUNKELER 27 AUG AFTER MEETING WITH TWO MBRS UNDERGROUND GROUP PROPOSING ARMS SHIPMENT REPORTED REF. IDEN CLAIMS GROUP PASSING IDEN 10,000 DOLLARS FOR USE BY IDEN PURCHASE ARMS AND RENT PLANE FOR SHIPMENT WHICH THEY WANT DELIVERED DOM REP NIGHT 31 AUG.
