AMBASSADOR HAS JUST BEEN APPRISED OF TAYLOR BRANCH STORY IN 23 OCTOBER ISSUE OF MIAMI NEWS IN WHICH RICARDO MORALES NAVARETTE IS IDENTIFIED AS CIA AGENT WITH PARTICIPATION IN OPERATION "MONGOOSE" AGAINST CUBA AND SERVICE AS MERCENTARY IN CONGO.
