1. Paul Marcel Victor Millietain was brought to the attention of the A.M.C.B.S by the subject of reference who visited Madrid from 16 to 21 February, 1959 and again during the week of 15 April 1959. MELLIETAIN, who at the time of the February visit was installed in the Hotel International, Madrid, reportedly has very good relations with King CARLOS of Spain, President DE VALLEJO of Leon, the royaluncio of Madrid, Thorevalian, Almudena, and RENAT A. AB. He also reportedly knows all of the FA members and has participated in all the FA meetings which have taken place in Madrid. On 10 September 1956 MELLIETAIN was sentenced to life imprisonment for murder and theft. (His victim was a student by the name of Paul GUTT.) On 13 December 1958 MELLIETAIN was sentenced to death and loss of all property by the High Criminal Court in Paris for collaboration with the enemy. MELLIETAIN is mentioned in the trial of General DE GAUL (7 August 1958) as a close confidant and advisor of MELLIETAIN. On 5 December 1955 MELLIETAIN married Alice Millietaine MAHLER (30 November 1923, Hanover, Germany) in Madrid. She is reportedly a doctor. They have since separated and she is now living in Berlin/Kensdorf, Berlinerstrasse 53-55. On 14 December 1955 she was issued a German passport (number 735-55) by the German Embassy, Madrid. MELLIETAIN is described as being intelligent and cultivated, but also very effeminate. The subject of [REDACTED] believes that MELLIETAIN is engaged in various illegal undertakings, but did not specify which these might be.

2. The Subject of [CHIA]70 reported to [REDACTED] that during his April visit to KETTERER the latter told him that he had recently been visited by IBM officials from West Berlin who had asked him to work for them and to establish his residence in West Berlin. KETTERER did not reveal to the Subject of [CHIA]70 what the nature of the work was to be, but he did state that he was going to take up residence at Berlin/Hermannstr., Berlinerstr. 53 (the address of his estranged wife). He added that the IBM officials promised to supply him with IBM documentation. KETTERER has tried unsuccessfully in the past to get West German documentation. (H. 1.8 Although he was born in Luxembourg, where this is now a stateless person.)
