SUBJECT: ANTI-CASTRO ACTIVITIES

1. ON 13 AUGUST 1963 A FAIRLY RELIABLE SOURCE REPORTED HE HAD BEEN CONTACTED BY ALEXANDER L. RORKE WHO INDICATED HE (RORKE) AND HIS FRIENDS, FRANK ANTHONY STURGES AND OSCAR MESTRE MASCARO, "WERE ALL SET TO DO SOMETHING"; THEY HAD AN AIRCRAFT OF UNDISCLOSED TYPE, AND NEEDED A BOAT. SOURCE SAID RORKE SEEMED TO BE SEARCHING FOR INDICATIONS AS TO WHETHER SOURCE WOULD GIVE ANY MONETARY SUPPORT TO HIS ACTIVITIES.

2. ON 15 AUGUST 1963, RORKE SHOWED SOURCE A PICTURE OF A GRUMAN BEARCAT AIRCRAFT ALLEGEDLY OWNED BY AN UNIDENTIFIED (BY RORKE) ANTI-CASTRO CUBAN EXILE STUDENT GROUP WITH WHICH RORKE CLAIMED TO BE ASSOCIATED. RORKE STATED THIS STUDENT GROUP WAS ATTEMPTING TO BUY A BOAT AND WAS THINKING OF SOMEBODY

A SOVIET SHIP OFF THE COAST OF NUEVITAS IN CALANCZY PROVINCE,  
CUBA.

3. ON 31 AUGUST 1962 HORKE TOLD SOURCE HE HAD SOMETHING  
TO DO WITH THE RECENT RAID AND SUELLING OF HABANA BY THE  
DIRECTORIO REVOLUCIONARIO ESTUDIANTIL (DRE) ORGANIZATION, AND  
THEY WERE GOING TO TAKE ACTION AGAIN SOON. HORKE ONCE AGAIN  
HINTED FOR AN INDICATION AS TO WHETHER SOURCE WOULD GIVE ANY  
MONETARY SUPPORT TO HIS ACTIVITIES.

4. ON 8 SEPTEMBER 1962 HORKE TOLD SOURCE HE HAD THREE BOATS  
INCLUDING CUBAN AND AMERICAN CREWS AND AN AIRCRAFT READY FOR  
RAIDS AGAINST CUBA. HORKE SAID HE WAS IN GREAT NEED OF ABOUT  
TWENTY TWO THOUSAND DOLLARS TO BUY GUNS AND AMMUNITION AND  
THAT A RAID WAS BEING PLANNED FOR NEXT WEEK. TARGETS FOR THE  
RAID ARE A PETROLEUM REFINERY AND NAVIGATIONAL AID ON THE  
NORTH COAST OF CUBA.

5. ON 8 SEPTEMBER 1962 SOURCE SAID HE HAD RECENTLY MET A  
REPRESENTATIVE OF THE AMERICAN (CONTINUED)

FOREIGN POWER AND LIGHT COMPANY, AND THIS REPRESENTATIVE STATED THAT THE COMPANY HAD BEEN IMPRESSED BY BORKE AND WERE CONSIDERING GIVING MONETARY ASSISTANCE TO BORKE IN HIS CASTRO ACTIONS. SOURCE SAID HE RECENTLY MET RUBY PHILLIPS, A NEW YORK TIMES CORRESPONDENT WHO TOLD SOURCE THAT RUBY PHILLIPS BOATS (PRESUMABLY IN MIAMI, FLORIDA). SOURCE SAID THAT RUBY PHILLIPS MAY HAVE SENT BORKE TO THE AMERICAN FOREIGN POWER AND LIGHT COMPANY TO SEEK FINANCIAL ASSISTANCE.

6. ON 29 AUGUST 1962 ANOTHER FAIRLY RELIABLE SOURCE REPORTED THAT BORKE HAD STATED THAT HE AND OTHER UNITED STATES CITIZENS WERE WORKING CLOSELY WITH LAUREANO BATISTA FALLA OF THE MOVIMIENTO DEMOCRATICO CRISTIANO. SOURCE SAID BORKE WAS ATTEMPTING TO GET ASSISTANCE FROM THE CENTRAL INTELLIGENCE AGENCY, OR AT LEAST THE SUPPORT OF THE AGENCY, TO PREVENT INTERFERENCE FROM OTHER UNITED STATES GOVERNMENT ELEMENTS IN HIS ANTI-CASTRO OPERATIONS.

7. ROME, NETHER, STURGES AND LAUREANO BATISTA FALLA  
HAVE BEEN THE SUBJECT OF PREVIOUS CORRESPONDENCE BETWEEN  
THIS AGENCY AND THE ABOVE. PRELIMINARY TRACES OF THIS AGENCY'S  
FILES REVEAL THE ABOVE INFORMATION ON RUBY PHILLIPS. AS ADDI-  
TIONAL INFORMATION CONCERNING THE ABOVE SUBJECT IS RECEIVED BY  
THIS AGENCY IT WILL BE PROMPTLY FORWARDED TO ADDRESSEES. THIS  
AGENCY WILL APPRECIATE RECEIPT OF ANY INFORMATION DEVELOPED  
BY ADDRESSEES ON THE ABOVE SUBJECT.

8. THE ABOVE INFORMATION IS BEING MADE AVAILABLE TO THE  
IMMIGRATION AND NATURALIZATION SERVICE, TO THE BUREAU OF CUSTOMS,  
AND TO THE BUREAU OF INTERNATIONAL PROGRAMS OF THE DEPARTMENT  
OF COMMERCE.
