1. SUBJ REF & NOW AMHIP ONE MUST AS PLANNED. HE FAIRLY CERTAIN AMHIP ONE (IDEN) WILL DEFECT AND AGREE TO KNOWLEDGE EXPLOITATION PER REFS.

2. ACCORDING AMHIP SUBJ INTERESTED CONSTRUCTIVE EMPLOYMENT AGAINST CASTRO REGIME AFTER DEFECTION RATHER THAN VEGETATE IN MIAMI. PROBABLY NOT INTERESTED AFFILIATING WITH PRESENT EXILE CUBAN GROUPS AND POLITICIANS. ADVISE WHETHER WAVE INTERESTED USING AMHIP IN KNOWLEDGE OR OTHER LONG TERM SIMILAR ASSIGNMENT. IN LIGHT CLOSE AFFILIATION CASTRO REGIME PERSONALITIES, CAN WAVE BE MOST APPROPRIATE USE? ~~ALSO INTERESTED IN KNOWLEDGE EXPLOITATION PER REFS.~~ ALTHOUGH FINAL DECISION DEPENDENT ON POST DEFECTION DEBRIEFING AND ASSESSMENT, DESIRE PRELIMINARY WAVE VIEWS BEFORE CASE OFFICER DEPARTS HQS 20 JULY SINCE WILL BE STRATEGIC IN DEFECTION FIT
