1. RE PARA 4 REF, HAVE NOT HAD TIME MAKE THOROUGH REVIEW FILE FOR COMPLETE ANALYSIS ⁰² UNSNAFU/5 KNOWLEDGEABILITY BUT FOLLOWING IS BASIC COUNT OF CASES HE KNOWS:
 - A. AMLASH/1, INCLUDING AMLASH/2, AMLASH/3, AMWHIP/1. ALTHOUGH IT CERTAIN ⁰² UNSNAFU/5 KNOWS OF INVOLVEMENT OF ALL ABOVE WITH KUBARK AND KNOWS GENERAL NATURE AMLASH/1 PLANS RE AMTHUG, IMPOSSIBLE ESTIMATE HIS KNOWLEDGE IN DEPTH SINCE SUCH KNOWLEDGE WOULD HAVE BEEN GAINED FROM AMLASH/1, AMWHIP/1, ⁰² UNSNAFU/9 DURING FREQUENT CONTACTS THEY HAVE HAD PARI. AMLASH/1 HAS EXPRESSED CONCERN OVER ⁰² UNSNAFU/5 CONDITION AS IT MIGHT AFFECT HIMSELF.
 - B. ⁰² UNSNAFU/9. ⁰² UNSNAFU/5 COMPLETELY KNOWLEDGEABLE ⁰² UNSNAFU/9 ACTIVITIES UP TO EARLY DECEMBER. AS HQS AWARE, ⁰² UNSNAFU/9 AND ⁰² UNSNAFU/13 ONLY REGULAR PARI AGENT PENETRATION OFFICIAL (PERUMEN) ESTABLISHMENT. WHILE LOW LEVEL, THEY HAVE VALUE.

 AWARE SPECIFICS.

F. KNOWS OF STOCKWOOD EFFORTS RECRUIT (U)NSNAFU/20 AND OUR INTEREST
 PENETRATE (U)NSNAFU/7 OFFICES BUT NOT WARE AUDIO ASPECT.

G. KNOWS GLOADEN, KYMINGHAM, GROWERY AND POSSIBLY OTHER CO'S
 [IN TRUE NAME. GENERAL KUBARK EEI'S FOR PBRUMEN.

* 2. (U)NSNAFU/5 DURING LAST THREE WEEKS OF STRESS HAS REPEATED TO
 CO SEVERAL TIMES THAT HE WOULD NEVER BETRAY SECRETS KNOWN AND BELIEVE
 HE MOST SINCERE IN THIS WHEN RATIONAL. HOWEVER, FROM ABOVE LISTING,
 IT OBVIOUS^{sf} THAT UNCONTROLLED REVELATION HIS KNOWLEDGE COULD BE
