1. VIEW REF CABLING FOLL ITEM FROM DISPATCH REGARDING CUBAN PERSONALITIES WHICH BASED ON AMBASSADOR ANTONIO CARRILLO CARRERAS REMARKS TO AMWHIP ONE SEP 29.
2. RAMON AJA CASTRO OF THE CUBAN EMBASSY IN MADRID WILL BE REMOVED SOON AND RETURNED TO CUBA. AJA IS ACTUALLY A MEMBER OF CUBAN STATE SECURITY AND IS NOT A CAREER DIPLOMAT. (SOURCE COMMENT: THOUGH AJA AND CARRILLO OFTEN SPEAK ILL OF EACH OTHER, THIS REMARK WAS MADE BY CARRILLO MORE BY WAY OF EXPLANATION OF AJA'S TRUE STATUS THAN AS A DENUNCIATION.)
3. ONE OF THE REASONS THAT AJA WILL BE RECALLED IS THAT HE FUMBLED A RECENT REQUEST BY CELIA SANCHEZ REGARDING THE TRAVEL OF A SISTER IN LAW OF SANCHEZ TO CANADA. THE RELATIVE WISHED TO SEE OTHER RELATIVES RESIDENT IN THE UNITED STATES. SANCHEZ HAD SENT WORD TO AJA TO SEE THAT ARRANGEMENTS WERE MADE FOR THE RELATIVE TO GET A CANADIAN VISA AFTER HER ARRIVAL IN SPAIN FROM CUBA. AJA DID NOTHING WHEREUPON SANCHEZ TOLD HER SISTER IN LAW BY TRANSATLANTIC PHONE TO SEE CARRILLO IN PARIS. CARRILLO TOOK CARE OF THE MATTER.
