1. MSG WHICH SUBJECT PARA TWO REF HAD FROM AMLASHONE WAS THAT LATTER WANTS SILENCER FOR THE BELGIAN FAL SUBMACHINEGUN SOONEST. THIS TO BE DELIVERED TO [Redacted] (AMWHIP NOT ABLE GET BETTER DESCRIPTION WEAPON BUT SAYS IT IS THE NATO WEAPON WHICH MILITIA CUBA CARRY).

2. SUBJECT PARA TWO REF LED BY AMWHIP THINK LATTER WILL TRY SILENCER TO CUBA VIA RELATIVES ITALY. ACTUALLY ^KUBARK WOULD HAVE TO DELIVER. IN IGNORANCE HQS KNOWLEDGE DETAILS STOCKWOOD ASKED TO WHAT ADDRESS ITEM COULD BE DELIVERED IF DESIRED DO SO. AMWHIP GAVE IDENS A DAND B ON ^{WHICH} AUPN "NICK" HAS BACKGROUND.
